“You are eligible for an offer and for which confirmation OTP has been sent on your mobile, please share the same....”

“Load 5 M-Pesa wallets with Rs XX, you will be get Rs XXX cashback.....”

“Load a M-Pesa wallet for Rs XX and a free glow sign board installed at your location.....”

- Never disclose confidential details like Card/Bank details, Passwords, OTP, PIN, with anyone.
